

Ultra-low Capacitance ESD/Surge Protection

General Description

SY205243AMC is an ultra-low capacitance electrostatic discharge (ESD) and surge protector designed to provide ESD protection for high-speed data interfaces. SY205243AMC is designed to protect against over-voltage and over-current transient events. It complies with IEC 61000-4-2 (ESD), (±30kV air, ±30kV contact discharge), and IEC 61000-4-5 (surge) (550W, 8/20µs).

The combined features of ultra-low capacitance and high ESD robustness make SY205243AMC ideal for applications where arrays are not practical. The low clamping voltage of the SY205243AMC guarantees minimum stress on the protected IC.



Circuit Diagram













Typical Operating Characteristics

Application Information

SY205243AMC is designed to protect one data line pair.





Figure 1. SY205243AMC Pin Connections in PCB

The SY205243AMC pin connections for RJ45 Ethernet line-to-line ESD and surge protection are shown in Figure 1. One RJ45 data line is connected to Pin1 of SY205243AMC. The other RJ45 line is connected to Pin2 of SY205243AMC. The SY205243AMC peak pulse current (IPP) rating of 20A can provide good line-to-line surge protection for the LAN PHY chip.




SOD-323 Taping Orientation
