













Typical Operating Characteristics

Application Information





Figure 1. SY205242AMC Pin Connections in PCB

SY205242AMC is designed to protect one data line pair. The SY205242AMC pin connections for RJ45 Ethernet line-to-line ESD and surge protection are shown in Figure 1.

One RJ45 data line is connected to Pin1 of SY205242AMC. The other RJ45 line is connected to Pin2 of SY205242AMC. The SY205242AMC peak pulse current (IPP) rating of 12A can provide good line-to-line surge protection for the LAN PHY chip.




